Legal Advice Clinic Privacy Notice

General Information

The Legal Advice Clinic is part of the University of Huddersfield and all our data processing is managed in accordance with the University Privacy Policy, which sets out when and how we collect, use, manage and store data. It also contains details of the University's Data Protection Officer, how you can exercise your rights as a data subject and details of our retention schedule. We shall process your personal data in accordance with the Data Protection Act 2018 (DPA) and the UK General Data Protection Regulation (GDPR).

This Notice is for the attention of clients or prospective clients of The University of Huddersfield's Legal Advice Clinic. This Notice explains how we will collect and use your personal data. The University of Huddersfield is the data controller for personal data that we process about you.

Updating our Privacy Notice

We keep this notice under regular review to ensure it is up to date and accurate. It was last updated in **June 2025**.

Our Website

When you visit the University's website, the University uses analytics and cookies to maintain and monitor the performance of our website. The legal basis for this is article 6(1)(f) of the UK General Data Protection Regulations (GDPR), which allows us to process data where necessary in our legitimate interests.

Our Site

The university operates a CCTV system for safety and security reasons and when you visit the campus you may be captured on CCTV. Our CCTV policy provides you with further information on our use of CCTV.

Legal Advice Clinic's Use of Data

Purpose and Legal Basis for Processing

The Legal bases we rely on for processing this data are:

- Article 6(1)(a) of the UK GDPR, which allows us to process personal data where you have given us your consent.
- Article 6(1)(b) of the UK GDPR, which allows us to process personal data as necessary for the performance of a contract that we have entered with you.
- Article 6(1)(c) of the UK GDPR where we need to comply with a legal obligation.
- Article 6(1)(f) of the UK GDPR, which allows us to process data where necessary in our legitimate interests, for example in managing our operations.

Conditions for processing sensitive personal data

Where we collect and process "special categories" of particularly sensitive personal information, these require higher levels of protection and we need to have further justification for processing this type of personal data. We may process special categories of personal data in limited circumstances with your explicit written consent under Article 9(2)(a).

The situations in which we might process your sensitive personal data are listed below:

• Processing to enable anonymised reporting, research or presentation of statistics through, for example, pseudonymisation.

We will use the information you provide about your health to ensure your safety when engaging
with the Legal Advice Clinic and where required to properly consider your case and provide appropriate
advice.

Why we need it?

We collect and process personal data about you in order to carry out our services as the Legal Advice Clinic; to manage our operations effectively, and to meet certain legal requirements.

We may use the data for research purposes and to report anonymised statistics.

Who do we share your data with?

The Legal Advice Clinic protects the personal data that it holds about you and the standard response to enquiries about individuals is that information cannot be disclosed to third parties without your consent (unless we are required to do so by law or regulatory authority).

The data is anonymised to provide statistics to the University, Law Works and any other third party in accordance with the University's privacy policy. The Law Works charity connects volunteer lawyers with people who require legal advice. Law Works use this data to identify which groups or communities are using pro bono legal services across the country and which others may benefit in the future.

However, there are occasions when we may need to share your personal data with third parties. We may share some of your data with our partner law firms, where they may be assisting with your case. In such cases, the legal basis we rely on is Article 6(1)(a) of the UK GDPR, which allows us to process personal data where you have given us your consent. How long we keep it?

We will only retain your personal information for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting or reporting requirements. In some circumstances we may anonymise your personal information so that it can no longer be associated with you, in which case we may use such information without further notice to you, for example to assist our students with their studies or for research purposes. We will keep records of your case while you remain a client and then for six years, after which your information will be securely destroyed.
